1. **USERRA Technician Information/Notification and Election Rights.**

[] I am a permanent, indefinite, or temporary employee. I have read the information concerning my election rights and benefits under USERRA.

2. **Position Status**

[] I am a **permanent or indefinite employee**. I elect to be placed on **AUS** from my technician position and have attached a completed SF-52 requesting AUS (USERRA).

[] I am a **permanent or indefinite employee**. I elect to **Separate** from my technician position and have attached a completed SF 52 requesting Separation-US (USERRA).

[] I am a **temporary employee** and elect to be placed on **AUS** from my technician position. I understand that my reemployment rights are limited to the established not to exceed (NTE) date of my temporary appointment and I will be terminated at that time if not reemployed. Attached is a completed SF-52 requesting AUS (USERRA).

[] I am a **temporary employee** and elect to **Separate** from my temporary technician position and have attached a completed SF-52 requesting Separation-US (USERRA). I understand that employment rights are limited to the established not to exceed (NTE) date of my temporary appointment.

3. **Leave Status.** I wish to use the following accrued leave **prior** to being separated or placed on a nonpay status. Only Comp Time needs to be used before AUS effective date and **MUST** be used first.

4. **Annual Leave.** Instead of using my accrued annual leave towards my active duty period, I request:

- A lump-sum payment of all my accrued annual leave.
- That you retain my annual leave in my leave account until I return to civilian service.

5. **Health Benefits (FEHB).**

Non-Contingency:

- I elect to continue my FEHB, up to 24 months while on military duty. I understand that I will pay only my share of the premium cost for the first 12 months. *[If you elect this option, you must also complete one of the two payment options below].* If I continue my FEHB after the first 12 months, I understand that I will pay 102% of the premium cost and it must be paid currently. I also understand that to be entitled to this additional twelve month coverage, I must continue to be eligible for reemployment rights.

- I want **to pay for my FEHB on a continuing basis** during my absence. Please provide me with the address of where to send my premium payments.

- I want **to incur a debt** to be paid upon my return to duty.

- I want **to terminate** my FEHB while on military duty. I understand that my FEHB coverage will continue at no cost for 31 days and that I am NOT eligible for temporary continuation of coverage (TCC). I understand that I must terminate my FEHB **within 60 days of being placed on AUS** or I will not be able to terminate my FEHB until an FEHB Open Season, or if I have if I have a qualifying life event unless I fill out the Pre-Tax Premium Conversion form within 60 days of my orders. I understand that this termination **is not** considered a break in service for continuing FEHB into retirement.
I understand that I may also be eligible for Transitional Tricare in which I will be responsible for notifying HRO in writing when Transitional Tricare begins and ends. I understand I terminate/reinstate my FEHB through <https://www.abc.army.mil> within 60 days of the date my orders begin/end or Transitional Tricare ends.

Contingency:

- I elect **to continue my FEHB**, up to 24 months while on military duty.

- I am being called to active duty in support of a contingency operation. My agency will pay my share of the premium up to 24 months from the effective

date of my orders. If after the 24 months, I am still on active duty my FEHB will be terminated.

[] I want **to terminate** my FEHB while on military duty. I understand that my FEHB coverage will continue at no cost for 31 days and that I am **NOT eligible** for temporary continuation of coverage (TCC). I understand that I must terminate my FEHB **within 60 days of being placed on AUS** or I will not be able to terminate my FEHB until an FEHB Open Season, or if I have a qualifying life event unless I fill out the Pre-Tax Premium Conversion form within 60 days of my orders. I understand that the Termination **is not** considered a break in service for continuing FEHB into retirement.

I understand that I may also be eligible for Transitional Tricare in which I will be responsible for notifying HRO in writing when Transitional Tricare begins and ends. I understand I terminate/reinstate my FEHB through <https://www.abc.army.mil> within 60 days of the date my orders begin/end or Transitional Tricare ends.

6. Federal Employees Group Life Insurance (FEGLI).

[] I understand that if I am placed on AUS, my FEGLI coverage will continue for up to 12 months at no cost to me. My coverage will continue an additional **12 months at my expense**. If I do not want to continue FEGLI coverage at my expense, If I separate my technician position, my FEGLI will continue at no cost to me for up to 12 months or until 90 days after my military service ends, whichever date comes first. Upon termination of coverage, I will be provided a 31-day temporary extension for conversion to a non-group policy.

[] I have FEGLI and have completed the FEGLI Program Election Form (attached)

7. Federal Employees Dental and Vision Insurance Plan (FEDVIP)

[] I understand that if placed on AUS, I may cancel my enrollment through www.benefeds.com or 1-877-888-3337 31 days before to 60 days after my order begins. To continue FEDVIP benefits while on active duty, you will receive a direct bill to make premiums. You are responsible for making sure Benefeds has your correct address to bill you and have made arrangements to have the bill paid on a current basis. For further information, contact Benefeds.

8. National Guard Association of the United States (NGAUS). I have the following NGAUS coverage, which I wish to continue or terminate as indicated below. I understand that if I elect to continue the coverage, I will be responsible for the premium cost after the waiver period (depending on type coverage) and/or direct-bill payments.
